To support our local, young entrepreneurs, Wenatchee Valley Farmers Market is delighted to bring you our very popular **KIDS MARKET** on 3 separate occasions this year. June 17th, July 15th, and August 19th from 9am-12pm.

This is a great opportunity for our next generation to learn about marketing and handling money while selling their own handcrafted or homegrown items in a fun and safe environment.

- Kids must be 14 years of age or younger and accompanied by a responsible adult.
- All products sold by Kid vendor must be made or grown by and sold by that child. No reselling.
- Each Kid vendor will be allowed one 6ft. table, in the designated "Kids Market" area to display their goods. Each Kid vendor will share a canopy with another Kid vendor. WVFM will supply the canopies.
- Due to needed permits and liability, no sampling will be allowed.
- Kid vendors selling fruits/produce may not accept any WVFM script or tokens.
- Kids Market hours are 9am-12pm. Please arrive no later than 8:30 for set up.
- Due to the popularity of the Kids Market and the limited space, there is no guarantee of admittance.

**WENATCHEE VALLEY FARMERS MARKET RULE APPLICABLE TO THE KIDS MARKET.**

**4.5 SIGNAGE:** Vendors MUST post a sign at least 432 square inches (18” x 24”). In size, identifying themselves and/or the farm name represented and where it is located. **THIS SIGN IS REQUIRED. All items in the booth must be clearly marked with their prices, whether an item is purchased by piece, pound, or box.** These can be done by individually tagging each item with a sign or by listing all products and prices on a large sign or blackboard. Signs must be tasteful and in good repair. All vendors are required to display prices in a legible manner.

\*For Kids Market, sign size can be 12”x12”

**4.11 STALL CLEANUP:** Each vendor is responsible for keeping his/her stall space clean during the Market and for complete cleanup of the space at the close of the Market day. This includes hauling away any trash or garbage that is generated in or around the stall and sweeping up any product debris left on the ground. Vendors are NOT to use the garbage cans left out for customers around the Market area, vendors need to use the garbage receptacle available through the Port of Wenatchee, behind Pybus Public Market.

**4.15 PETS: NO PETS ALLOWED IN BOOTHS,** except service animals. Service animals must meet the state required criteria/definition and vendor must have appropriate paperwork on person or in booth.
